WHEREAS, the City will permit same if the Observer agrees to certain stipulations:

NOW THEREFORE, it is agreed as follows:

1. That the Observer may accompany a police officer in an Annapolis City Police vehicle during the officer's tour of duty.
2. That the Observer for himself, his heirs, executors and personal representatives agrees to hold the Mayor and Alderman of the City of Annapolis harmless from any injury, death or any kind of claim whatsoever as a result of the Observer accompanying the police officer aforesaid.
3. That the Observer agrees that the Police Department of the City of Annapolis, or any of its officer, may review and eliminate if necessary, material gathered by the Observer at its sole discretion.
4. That the Observer will refrain from entering onto the private property of or making inquiries of victims, suspects or other citizens who might misinterpret his/her action as acting under color of law.
5. That the Observer shall not publish or disseminate any evidentiary material or statements until the cases in question are finalized.
6. That the Observer has also signed this agreement and is bound by all of the terms of this agreement.
